## Emergency Market Surcharge (EMS)

Most trade lanes are facing significant space constraints, and carriers are dedicating a rising share of their allocations to premium rate bookings. Long-term, named account bookings are more and more restricted, and container availability continues to be a challenge.

As a result of these general market conditions and to better ensure your supply chain continuity, your equipment availability, and your bookings, CEVA Logistics has decided to implement an **Emergency Market Surcharge (EMS)** as part of our Ocean Freight rate structure. CEVA is continuously monitoring the market situation and will provide further information and updates when available. This EMS is subject to regular reviews, and your rates will remain aligned to market conditions.
